Blue Course – Expert, Youth A,B

Blue / Yellow Course – Clubman Expert, Youth A,B,

Yellow Course – Clubman, Youth A,B,C

Yellow / White Course – Mono N/E, Twinshock N/E, Youth A,B,C

White Course – Mono Novice, Twinshock, Pre 65, Trail, Youth A,B,C,D.

Green Course – Adult Beginner/Veteran, Youth Beginner

Please note Youth entries must be riding petrol machines

AWARDS in all classes – Win, 2nd, 3rd. No competitor may win more than one award.

COURSE: - 3 laps of 8 sections all on private land. Sections shall be ridden in correct order on each lap where possible. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

METHOD of MARKING: - As per **TSR 22b; (no stop)**. Ties will be resolved as per TSR 23.

PROTESTS:- as per the National Sporting Code of the ACU, section 10.04.

GENERAL: Please adhere to all signage as instructed by Officials.

Please take all your litter home.

NO ENGINES TO BE STARTED UNTIL THE START OF THE TRIAL AND NO RIDING IN START AREA BEFORE OR AFTER THE EVENT.

IMPORTANT MESSAGE - Please will you ensure that you approach and leave the event and local area in a responsible, legal and neighbourly manner. Please be aware that these roads are also used by horses, cyclists and pedestrians. Thank you.

COVID 19: The event will be run under the current guidelines issued by the Government and the ACU and must be adhered to.

Start Times: Riders will commence the trial in a group at a specific start time.

Parking at Sections: We ask that on arrival at a section all riders observe social distancing.

Inspecting Section: We ask that you and your group of riders inspect it without lingering and observing social distancing.
